This is notified for general information that Kaziranga National Park will be open for visitors from 12<sup>th</sup> of October 2018 for the coming tourist season 2018-19.

However, it is hereby informed that due to inclement weather and existing poor road conditions, owing to the recent floods, only two of the four ranges, namely, the Central Range, Kohora and Western Range, Bagori will be accessible for the visitors until further orders.

Also, the Jeep Safari in Central Range, Kohora and Western Range, Bagori will be operational for only about 8Kms and 6.5 Kms respectively. The accessibility of the complete tourist tract is subject to weather and road condition and will be notified subsequently.

The date for opening of elephant ride for the tourist's will be notified in due course of time.
